DEED OF APPOINTMENT

is made the

*thirtieth* day of *August* One thousand nine hundred and forty four BETWEEN HENRY HOSKEN of the City of Truro in the County of Cornwall Company Director WILLIAM BATE of the Parish of Gwithian in the said County Analytical Chemist (retired) JOHN ELLIS (Gentleman) CHARLES VIVIAN WILLS (Company Director) and FREDERICK ARTHUR TROTT (Horticulturist) all of Hayle in the said County (hereinafter called "the continuing trustees") of the one part and FRANK HAYWOOD WALTER of Penpol Terrace Hayle aforesaid Insurance Secretary and DENNIS JOHN PEARCE of Commercial Road Hayle aforesaid Grocer (hereinafter called "the new trustees") of the other part

WHEREAS:-

- (1) This deed is supplemental to the deeds set out in the Schedule hereto
- (2) The said Henry Harvey Trevithick died on the thirteenth day of December One thousand nine hundred and forty one
- (3) The said Richard Hodge died on the fifteenth day of April One thousand nine hundred and thirty seven

NOW THIS DEED WITNESSETH as follows:-

1. THE said Henry Hosken William Bate John Ellis Charles Vivian Wills and Frederick Arthur Trott in exercise of the power for this purpose conferred by statute or of powers contained in the Deeds numbered 1, 2, 3 and 4 (hereinafter referred to as the "principal deeds") set out in the Schedule hereto and of all other powers (if any) them hereunto enabling hereby appoint the said Frank Haywood Walter and Dennis John Pearce to be trustees of the principal deeds in the places of the said Henry Harvey Trevithick deceased and Richard Hodge deceased and jointly with the said Henry Hosken William Bate John Ellis Charles Vivian Wills and Frederick Arthur Trott.

2. THE said Henry Hosken William Bate John Ellis Charles Vivian Wills and Frederick Arthur Trott do hereby respectively declare that the hereditaments comprised in the principal deeds shall forthwith vest in the said Henry Hosken William Bate John Ellis Charles Vivian Wills Frederick Arthur Trott Frank Haywood Walter and Dennis John Pearce as joint tenants in fee simple upon the trusts affecting the same under the principal deeds or either of them respectively
